

Behavior Requirements & Responsibilities: (In order to clarify some recent confusion)

- AMIASs need to be aware of, understand, and follow the requirements and responsibilities in (1) the SCWS Area Safety & Behavioral Requirements, effective 6-1-13; (2) WSO G-34 Alateen Safety Guidelines; and (3) Alateen Service Manual - Alateen Policy.
- Primary responsibilities of each AMIAS is to ensure the safety of Alateens and Alateen meetings and events and to ensure that the Twelve Traditions are being upheld.
- As part of ensuring this safety Alateen Group/Event Sponsors (and any AMIAS serving as chaprone) need always be aware of the specific whereabouts of individual Alateen members at all times.
- AMIASs must set appropriate boundaries with every Alateen. Remember, as an AMIAS, you are not the Alateen's counselor, parent or peer.
- Alateen members are responsible for their behavior; remembering that what they do reflects on their group/event, the Conference or Assembly and the name of Alateen.
- An Alateen member who is legally an adult must adhere to the same requirements as the Alateen members who are minors when participating in Alateen.

When your shift is over, Please cancel the phone forwarding by logging out: Follow steps 1 thru 5, then un-check the box of step 6, skip step 7 and then click Apply.


